DALITE: You see the race track (reference probably to Hazel Park race track) has certain rules and if you live up to the rules you get a license. Here if they don't like the way you part your hair, you don't get a license. If we weren't a privileged industry, we could do something about that, but we are you know.

ROEN: But maybe we can talk to all these people - -.

DALITZ: Well I'll say this, we have never been stronger in our influence of these people than at the present time. We have got OLSEN now (probably a reference to ARTHUR OLSEN, recently re-elected Clark County Commissioner).

LV 10-C advised on 11/2/62 that NUBY KOLOD, casino manager, Desert Inn Hotel, Las Vegas, Nevada, and Las Vegas Criminal Intelligence subject, made a reservation for four for "POLIZZI" who was to arrive on 11/2/62. POLIZZI did not check into the hotel, however, ANTHONY ZEMILLI, 1850 Ten Mile Road, and DOMINIC CORRADO, 701 Middlesex, Grosse Pointe Park, Michigan, did check in and were assigned the rooms reserved for POLIZZI.

LV 10-C advised on 11/7/62 that ZERILLI and CORRADO were still at the Desert Inn Hotel and were to remain there indefinitely. Telephone calls were made by ZERILLI to the following numbers in Detroit on 11/6/62:

On the same date CORRADO telephonically contacted PETE BLANCA at 961 5110, Detroit, and he also made two other calls to 823 0782, Detroit, Michigan.

DALITZ, ROEN, and their associates have recently discussed the possibility of constructing a 500 room hotel near Reno. Nevada. It appears the above conversation relates to this matter and POLIEZI, ZERILLI, et al are now possibly interested in constructing and/or operating such a hotel. ROEN apparently gave them little encouragement and DALITZ is of the opinion they would never be able to secure a state license. Provious reference has been made to "RICH", who has the option on the land near Reno on which the hotel is to be constructed. This individual is possibly T. W. RICHARDSON, a long time Reno resident and gambler.
