LV 10-C advised that ZERILLI, MICHAEL POLIZZI, LOUIS ELIAS and ALEX MASHOUR, all of Detroit, Michigan, checked into the Desert Inn Motel, Las Vegas, Nevada, on 5/1/63. ZERILLI and POLIZZI occupied one room together and ELIAS and MASHOUR occupied another room together. Their reservations were made by RUBY KOLOD, hotel executive and Las Vegas Criminal Intelligence subject.

On 5/3/63, EMPILLI called #322-6310, Detroit, and on the same date HASHOUR called JOSEPHINE HASHOUR, #857-3608, Detroit. They were all still at the hotel on 5/0/63.

LV 70-CP adviced on 5/4/63 that on this date MORKIS B. DALITZ, dominant figure connected with the Desert Inn Hotel, Les Vegas, and Les Vegas subject, was in contact with HAJOR RIDDLE, President of the Dunes Hotel. DALITZ requested RIDDLE to contact Governor CRANT SAVYER of Nevada and determine from him if he feels gaming authorities would be willing to grant an owner's license to ZERILLE. ZERILLE and the group he represents are considering purchasing the Hew Frontier Hotel, Les Vegas, and constructing an addition
