In view of information reported by BU 82-C\* to the effect MAGADDINO is "boss", will attempt to determine stature of FALCONE and his associate members in relation to the MAGADDINO "family".

BALTIMORE DIVISION

The existence of a "Baltimore group" in the organized criminal element was the subject of conversations as reported by NY 3844-C\* on 12/19/62, as reflected in NY airtel to Bureau, dated 1/4/63, captioned, "JULIUS SALSBURY, aka; AR; IGA-NUMBERS LOTTERY," (OO - BALTIMORE).

The information developed indicates payoffs to "the Baltimore group". FRANK CORBI was mentioned as being with this group, and having a "boss".

It is noted that a Boston source BS 812-C, has furnished information to the effect that FRANK CORBO was a big man in Baltimore.

In view of the above information Baltimore will continue efforts to determine existence, organization, leadership and membership of an organized criminal element group in that area.
