By Legat, Mexico, letter to the Bureau, dated December 28, 1964, it was advised that on December 19, 1964, this matter and the fact that the subject, ANTULIO RAMIREZ ORTIZ, is a fugitive was discussed with recently appointed Chief of the Immigration Inspection Department, Mr. CRESCENCIANO CAMPOS, who advised that he thought it unlikely that the Mexican Immigration Department would issue a permit for the subject to travel to Mexico from Cuba if consulted prior to the subject's departure from Cuba.
