It is noted inasmuch as he is a United States citizen, and has previously been in contact with the Swiss Embassy in Havana, such information can be more expeditiously handled through Legat, Bern.] Legats, Mexico City and Ottawa, are being furnished copies of this memorandum, and are requested to place appropriate stops with proper sources in order that any information concerning RAMIREZ's possible travel to the United States will be brought to the attention of Legats immediately.
