The Department of Citizenship and Immigration has advised that their records do not contain any information which would indicate that RAMIREZ has entered or attempted to enter Canada. Lookout notices have been circulated to all Regional Immigration Offices.

2. We have been unable to identify RAMIREZ in our Identification Branch records on the basis of available information. A Stop Notice has been filed, however, you may wish to forward fingerprints, in order to ensure that this subject is identified in the event he is arrested in Canada.
