Following receipt of Miami communications regarding subject, this matter was again discussed with the Mexican Immigration Inspection Department. Attorney JORGE VAZQUEZ ROBLES, Chief of the Department, advised that stops remain outstanding for the subject and that stops are also outstanding at the Mexican Immigration Office at the International Airport in order that the subject can be placed under control, should he arrive at the Airport from Cuba without proper documents. *X (G-1)(U)*

Copies of subject's fingerprints have also been filed with the Metropolitan Police and the Judicial Police of the Federal District and Territories, Mexico City, in the event he should gain entrance to Mexico and be arrested by one of these agencies. *X (G-1)(U)*

The above-mentioned police agencies and Mexican Immigration will continue to remain on the alert concerning subject's possible travel to the United States through Mexico. *X (G-1)(U)*
