On 5/23/69, appropriate background data concerning subject and his fugitive status was furnished in writing, in Spanish, on a confidential basis to Attorney JORGE VAZQUEZ ROBLES, Chief of the Inspection Service of Mexican Immigration, and to Captain FERNANDO GUTIERREZ BARRIOS, Chief of the Mexican Federal Security Police. (G-1)(u)

It is noted that clearance must be obtained from these agencies before anyone is given a permit to enter or transit Mexico from Cuba. (G-1)(u)

These officials advised that this office would be notified if subject makes any attempt to come to Mexico. (G-1)(u)
