Re Legat, Ottawa letter to Bureau, 7/8/69.

During March, 1969, the subject, who resided in Cuba, applied to the Swiss Embassy, Havana, Cuba, for a Swiss Protection Passport indicating that he would like to depart immediately for the United States. Stops on the subject were placed with [the Royal Canadian Mounted Police, Ottawa, Canada, the Mexican Federal Security Police, Mexico City, and] Immigration and Naturalization Service, Brownsville, Texas.

Since there is no indication that the subject has been issued a Swiss Protection Passport, this case is being placed in a pending, inactive status.
