SAID COFRESI WAS THE NAME OF OLD TIME BUCCANEER WHO OPERATED BETWEEN PUERTO RICO AND THE DOMINICAN REPUBLIC, AND THEREFORE WAS OF THE OPINION THAT SUBJECT WAS POSSIBLY EITHER PUERTO RICAN OR DOMINICAN RATHER THAN CUBAN BECAUSE OF THE USE OF THIS NAME. [REDACTED]
