Re: General Conditions, Organizations  
and Subversive Activities Amongst  
Cubans - U.S.A.

This letter is further to our previous one to you dated the 23 July 1976.

2. Further contact with the Cubans while they were in Montreal has revealed the following data on thirty-one (31) Anti-Castro Cuban Exile (ACE) terrorists:

(Believed to be the same person as previously mentioned, only Jorge ~~JANERO~~ originally on Cuban list)

~~Jesus E. LAZO RIVERO~~  
~~DOB: 15 Oct 1924~~

(Probably the same person as previously mentioned)

~~Guido MARTINEZ VILCHES~~  
~~DOB: 27 Jan 1933~~

(Unable to decide between MARTINEZ VILCHES or MARTINEZ MUNOZ. Cannot identify or match name with photograph)

~~Guido MARTINEZ MUNOZ~~  
~~DOB: 28 Dec 1929~~

(Cannot match name with photograph because of the similarity between VILCHES and MUNOZ. Cubans originally gave the name Guido MARTINEZ)

~~Guillermo A. MIGUEL SANCHEZ~~  
~~DOB: 21 Apr 1930~~

(Believed to be the same person as Guillermo MIGUEL previously mentioned by the Cubans. Birthdate matches FBI)

~~Orlando D. ATITZA PEREZ~~  
~~DOB: 20 Nov 1938~~

(Not previously mentioned by the Cubans. However, could possibly be Orlando ATIENZA)

~~Ramon A. ROSCO~~  
~~DOB: 7 Aug 1951~~

(Believed to be the same person as previously mentioned by the Cubans)

~~Ramiro DE LAE PEREZ~~  
~~DOB: 6 Sept 1920~~

(Identified as the same person previously mentioned by the Cubans)

~~Alonso Inocencio VERA~~  
~~DOB: 28 Jul 1928~~

(Not believed to be same person as Aldo VERA previously mentioned by the Cubans)

~~Juan J. PERULLERO RODRIGUEZ~~  
~~DOB: 8 Mar 1930~~

(Probably the same person as Juan Jose PERUYERO previously referred to by the Cubans)

~~Guillermo Novo MOREJON~~  
~~DOB: 10 Feb 1923~~

(Appears that Novo MOREJON is not the same person as Novo SAMPOR previously identified by us)

~~Rafael L. SERRALTA NOGUES~~  
~~DOB: 2 Aug 1928~~

(Identified as the same person as previously mentioned by the Cubans)

~~DOB: 13 Mar 1930~~

(Originally referred to by the Cubans as Oscar Luis ACEVEDO. The FBI points out spelling should be Oscar Luis ACEREDO. Cuban and FBI DOB's match. Therefore it is felt that all are talking about the same person. This individual has been identified)

~~Carlos VARONA VARJONA~~  
~~DOB: 21 Mar 1938~~

(Originally referred to by the Cubans as Carlos DE VARONA. The FBI had no record of a DE VARONA)

~~Israel PINO SOSA~~  
~~DOB: 31 May 1932~~

(The Cubans referred to a Israel DEL PINO originally. The FBI believed DEL PINO to be the same person as Israel PINO-RAMOS, DOB: 29 Aug 36. Obviously they are not the same person)

~~Israel PINO CASTRO~~  
~~DOB: 20 Jan 1932~~

(The three PINO's mentioned are not the same person and it is impossible to match the correct one to the photograph without further particulars)

~~Israel PINO SPENGLER~~  
~~DOB: 13 Mar 1940~~

(Cannot establish which Israel PINO matches the photograph. Therefore we cannot identify subject accurately)

~~Orlando BOSCH MELUSA~~  
~~DOB: 19 Nov 1915~~

(It has now been established that the Orlando BOSCH previously referred to by the Cubans and identified as Orlando BOSCH AVILA are not one and the same persons. We also cannot establish whether or not Orlando BOSCH and Orlando BOSCH MELUSA are one and the same person)

~~Luis M. FABIAN PENDAS~~  
~~DOB: 16 May 1928~~

(The FABIAN previously mentioned by the Cubans and the Luis M. FABIAN PENDAS mentioned here are probably the same person and the name, DOB and photograph represent one and the same person)

~~Hector Alfonso RUIZ~~  
~~DOB: 12 May 1939~~

(RUIZ has been identified)

~~Adel SALVADOR GLEZ~~  
~~DOB: 6 Aug 1943~~

(Not previously referred to by the Cubans)

~~Jesus DOMINGUEZ BENITEZ~~  
~~DOB: 15 Feb 1941~~

(BENITEZ has been identified)

~~Ramon OROSCO RODRIGUEZ~~  
~~DOB: 24 Aug 1929~~

(Cannot identify OROSCO RODRIGUEZ definitely. He could also be identical to the original name referred to by the Cuban and could match the photo. Currently we have three Ramon OROSCO's listed;
