IT IS NECESSARY TO EMPHASIZE THAT THE MIAMI OFFICE HAS
[FIVE DOUBLE AGENT OPERATIONS IN THE CUBAN FIELD.] ASSETS (S)
IN THIS AREA ARE THEMSELVES [ASSOCIATED WITH EXILE TERRORISTS,
AND WERE IN FACT [RECRUITED BY THE CUBAN INTELLIGENCE SERVICE (S)
BECAUSE OF THEIR CONNECTION [WITH THESE TERRORISTS. (S) IN OUR
EFFORTS TO [NEUTRALIZE AND COUNTER THE CUIS,] WE MUST BE ABLE (S)

FROM THE [CUI THROUGH THEIR AGENTS.] BY HAVING [DOUBLE AGENTS] (S)
[WITHIN THEIR RANKS WHOM WE CONTROL,] WE MUST THEN BE ABLE TO (S)
