no possibility that he could obtain this photograph. He said this was an official photograph forwarded to NY from headquarters in Moscow, and said that he did not know in whose custody this photograph was at the present time. Informant said, however, that it would certainly be in the custody of one of the officials of KGB in the NY Residency, and presumed that either GABELKO, TITOV or Colonel BORIS IVANOV would have it. He thought it most likely that TITOV had it.

At this time informant again casually inspected the 3 photographs of YURI NOSENKO, which had been shown to him on a previous occasion by interviewing agents. Informant studied the photographs for several minutes, and then stated that one of these 3 photographs bore a faint, vague similarity to the photograph of NOSENKO which had been shown to him by GABELKO and TITOV. Informant commented that the photograph of NOSENKO, as shown to him by his KGB compatriots, appeared to be a very old photograph, and informant noted that upon looking at NOSENKO's picture, when GABELKO handed it to him, he was struck by the vague similarity in appearance between NOSENKO and Colonel VIKTOR TITOV.
