Reference is made to Document 573, dated 5/1/75, page 6, wherein it is indicated that ALEKSANDR RYZHUKHIN, a "Line S" officer currently assigned to the NY KGB Residency, had questioned the informant regarding any "Line X" possibilities through whom information might be obtained concerning a Syrian who was attending Columbia University and living at the International House at Columbia. When questioned concerning this situation informant stated that he had no current information in relation to this matter.
- 3. Informant was questioned as to any current information in his possession concerning the EALDSPOT (S) subject who allegedly had a meeting with EDUARD SERDINOV at the intersection of Northern and Junction Soulevards, Queens, NY, on (2/15/75,00) Informant stated that he had no additional information concerning this matter.
- 4. When questioned, informant could offer no information concerning the activities of ABDULKHALIK GADZHIYEV, a "PR" officer currently assigned to the NY KGB Residency, in relation to the TRINKET and RAPAHOE subjects.
- 5. Informant was also questioned concerning the PADACEL matter and in response to questions, informant stated that he had no information regarding a trip to the Boston, Mass., area by "KR", NY, 1) Secondly, informant had no information as to which "KR", NY, officer, if any, will make the Boston, Mass, trip in relation to the PADACEL matter. 1)

Comments Regarding NOSENKO/OSWALD

As the Bureau is aware, there has been recent newspaper and television publicity indicating that Soviet defector YURIY NOSENKO has provided information indicating that LEE HARVEY OSWALD, although not recruited by the KGB, was a counterintelligence problem to that organization while OSWALD was in the Soviet Union.
