He stated he understood LEO ADEEB, who operates an insurance agency and RICHARD OSBORNE, a public relations man, have formed a new public relations counseling concern.

MM-665-C-on-8/3/60, stated he heard MIKE MC LANEY is now connected in gambling at Haiti. He also stated MC LANEY's wife is divorcing MC LANEY after about a year's marriage. He further stated he was told that the wife of MC LANEY loaned MIKE MC LANEY \$85,000.00 for his operation in the Nacional and is trying to get it back.

MM 509-C on 7/15/60, advised that DAN LAPIDAS, who also known as DUSTY PETERS, has been in the Midtown Social Club, Miami Beach, Florida, off and on and is still making trips back and forth to Havana, Cuba.

MM 509-C on 7/8/60, advised that DAN LAPIDAS, also known as Dusty Peters, made a trip to Havana, Cuba, last weekend to look after some of his interests there.

He also stated he was told CHARLEY SCHWARTZ, a gambling casino manager, and GEORGE SHERMAN, a gambling pit boss, are still staying and working in Havana, Cuba.

RANDY KIPPLE, Manager, Biscayne Terrace Hotel, Miami, Florida, on 5/9/60, advised MIKE MC LANEY was a member of the Racquet Club, North Bay Village, Florida.
