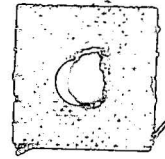
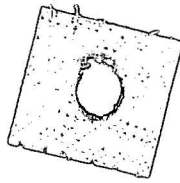

WEEKLY SUMMARY

MM 509-C-TE advised that SAMMY WEISS, sh/lock and owner of some liquor stores and his nephew JAY WEISS, a close personal friend of RICHARD GERSTEIN, Dade County State Attorney, have leased the Penthouse Lounge in the Harbor Towers Apartment, North Bay Village, Fla., from MARVE DUBIN, alleged friend of the hoodlum element.

MM 942-C reported JOSEPH BISOGNO, aka Joe Bruno (MM 92-1093), ANTHONY ESPERTI (MM 92-1402) took over Parisi's Restaurant from JOHNNY PARISI on 9/10/65. He also reported they are in addition operating the Green Parrott and the Flamingo Lounges in Hialeah, Fla.

MM 752-C advised that ANTHONY RUSSO (MM 92-729) and his close friend, NICK ANGEL, received letters from the Racquet Club, North Bay Village, Fla., cancelling their membership in this club.

MM 855-C-TE related that JACK COOPER, former part owner of the Flagler Dog Track in Miami, who had been convicted of an IRS violation and who hangs around the Bayshore Golf Club, also a hoodlum hangout, and some others, have acquired a London, England gambling place.

MM 764-C-TE advised that BEN NOVACK (MM 92-1285) and his associates are still being considered for the Cat Cay Club and gambling casino at Cat Cay, Bahama Island by the Bahamian Government.
