ANTI-RACKETEERING

On December 18, 1959, HAV-31 advised that he had been unable to develop any specific information that ERICKSON still retains any interest in the gambling casino at the Hotel Nacional in Cuba.

On January 7, 1959, source informed that there were some rumors that ~~MIKE~~ ^{Cuba}McLANEY might have some "Frank Erickson money" financing him at the Hotel Nacional casino.

No further information has come to the attention of the Legat, Havana, concerning any possible interest that ERICKSON might have in Cuban gambling.
