Re Miami letter with letterhead memorandum as enclosure, 6/7/63, and Bureau Bureau routing slip to Miami, 6/13/63.

Enclosed are six copies of an amended page which the Bureau and New York are requested to add to the letterhead memorandum furnished by Miami on June 7, 1963 as page 5.

For the information of the Bureau, the information furnished relative to MC LANEY was obtained from MM 856-C and MICHAEL MC LANEY, a PCI of the Miami Office, on a confidential basis. Their identity was not divulged in the letterhead memorandum; to do so would compromise their effectiveness to the Bureau, as well as violate a trust, as the information was obtained with the understanding their identity would remain confidential. MC LANEY in furnishing information concerning himself has stipulated that same be kept confidential insofar as his identity is concerned.
