MICHAEL J. MC LANEY (former MM 764-C-TE) on 8/25 and 8/26/69, advised that he secured a contract with the Haitian Government to operate the International Casino in Port-au-Prince, Haiti, to open any additional gambling casinos in Haiti and place slot machines in some of the Haitian hotels. This contract is for ten years and covers a graduated rental, etc. The gambling casino is scheduled for opening on 10/1/69.

MC LANEY claims he never bought the contract, meaning that he never paid anyone to secure same or promised anyone any sum or consideration to obtain it. He also states he intends to bar the hoodlum element and will supply the Miami Office a list of his employees he intends to employ, as well as other information concerning his operation and any other information coming to his attention which he believes may be of value to this Bureau.

One copy is being forwarded to New York Office for information because MC LANEY and others were indicted in New York City on 7/1/69, for Conspiracy, Mail Fraud, Wire Fraud and Perjury.
