Information has been received that MICHAEL McLANEY, who has been identified as having had an interest in Bahamian gambling matters, and who has been reported in the press as having been in an advisory capacity on these matters to Premier LYNDEN O. PINDLING of the Bahama Islands, has been told by an unidentified source that an attempt may be made to injure Premier PINDLING. This individual advised McLANEY that "racket individuals" are dissatisfied with the current restrictions placed on casino gambling in the Bahamas and hold PINDLING responsible for these restrictions.

The unidentified source who contacted McLANEY was said to have been drinking, but was not identified as being intoxicated.

The information above was furnished telephonically to Assistant Commissioner STANLEY R. MOIR, Bahamas Police Force, Nassau. McLANEY also furnished same to JAMES SHEPARD, a Bahamian representative who is on a trip with PINDLING, and to ALBERT A. FOULKES, a member of House of Assembly.

The above information relative to Premier PINDLING is being furnished for your information.
