Florida. The informant was led to believe that aboard this ship, was a place where gambling took place and also prostitution. The informant later obtained a card on Cocoa Beach, Florida which indicated that one could obtain dining and dancing aboard the luxurious 164 foot ship "Estuary Queen" and the host, MIKE CVEREKO, telephone # 784-0555. The informat further advised that according to the information he picked up this boat comes into the Cocoa Beach

area once or twice per month, no specific dates supplied.

A review of the 1967-68 Criss Cross Telephone Directory determined that telephone # 784-0555 is subscribed to by the ABC Answering Service.

Efforts to dentify the Estuary Queen have been negative to date although it has been determined that a similar type operation was done with a vessel known as the Orange Sun which was based in Miami several years ago. However this vessel is 165 feet in length and reportedly is in the Jacksonville area at the present time. Reportedly HARRY COHEN and MIKE MCLANEY. Pinetree Drive, Miami Beach, Florida had the gambling action on the Orange Sun. In addition it was reported that HARRY COHEN, MIKE McLANEY and SYMANDELL went to a reputable attorney in the Miami, Florida area in the past several months and inquired as to how to run an operation similar to that which was on the Orange Sun several years ago. These individuals impired how to operate this gambling ship in a legal fashion and the attorney whose identity is unknown, took offenseeat the inquiry and
