INFORMANT INFORMATION:

LV 440-C advised SA FRANK W. CORNETT on 4/30/70, that to his knowledge subject continues to play cards and frequent race and sports book, but informant had no information that subject furnishes "line information" out of the State of Nevada.

LV 440-C was again contacted on 6/2/70, regarding subject, and he advised he occasionally deserves subject in the Las Vegas race and sports books but has no information indicating that subject is furnishing line information.

On 3/24/70, CSDE 1394-C advised that Detroit telephone number 364-8063, a non-published number, had been assigned to JOHN J. LEUCHTMAN, 14031 Vassar, Detroit, Michigan, and that this number was removed on 10/2/69.

It was noted in Las Vegas report of SA FRANK W. CORNETT, dated 3/3/70, that the above number was in contact with Las Vegas telephone number 870-7671 on 8/17/69.

On 3/27/70, the records of the Detroit PD were reviewed by IC HERBERT C. LAVOIE am no record identifiable with JOHN J. LEUCHTMAN was located. The records of the Wayne County SO, Detroit, were reviewed by IC LAVOIE with negative results on 3/28/70.

On 4/9/70, the records of the Credit Bureau of Greater Detroit, Inc., did not reveal a record identifiable with LEUCHTMAN.

The records of the Detroit Office reveal a case titled, "JOHN J. LEUCHTMAN, SM-C, INTERNAL SECURITY ACT 1950", Detroit file 100-2127. This file revealed that LEUCHTMAN, born 5/17/98, at New York City, was employed in 1953 by Mercury Engineering, Detroit, Michigan, and in 1931 - 1933 was employed in Russia as a specialist in Sheet Metal Engineering.

On 3/6/70, investigation at Chicago determined that telephone number 585-4168 was unlisted and not available to public.
