Pindling in the Bahamas. (5) The requested investigation appears to relate directly to the internal affairsy of the Bahamas since you have advised that there is a question with respect to the extent to which Mr. Pindling and his ministers should be alerted against maintaining undesirable associates. As a result of a careful review of the information available in your memorandum of February 9, 1967, we find from the facts given that the activities of these individuals are not indicated to be in violation of laws within our jurisdiction and, further, that it appears that the named individuals are most frequently found in the Bahamas. (5) In view of the foregoing circumstances, we do not feel a violation present which would enable the Bureau to enter an investigation of their activities. It is noted, too, that the subjects in whom you have expressed an interest are most frequently found in the Bahamas. Effective interviews by the FBI of these individuals in connection with internal matters of the Bahamas, an area in which we have no jurisdiction, would be inapprepriate (5) Your referenced letter also advises of allegations indicating the subjects may have been interested in the trafficking of arms. In this connection it is pointed out that jurisdiction over such activities insofar as they relate to the United States and within the jurisdiction of the Bureau of Customs in the Treasury Department.
