In addition to the information reported in the details attributed to MM T-1, it is noted that this informant (TP 187-S*) after the meeting between CP-USA organizers and the Miami pro-CASTRO element, was given letters to be delivered to ALFREDO MORENO (not further identified) in New York, by RAUL ANDRE, one of the pro-CASTRO leaders in attendance at the meeting.
