The above code name has been assigned to a Cuban alien whose activities are being directed against the Cuban Intelligence Service. He has been given the assignment by his Cuban principal of obtaining information relating to anti-Castro activities against Cuba. Through his contacts with members of the anti-Castro element in Miami, Florida, he has obtained the following information:

Rolando Masferrer is in Miami and is staying with his brother at 2368 Southwest 12th Street, telephone HI 6-7772. Masferrer has been making extensive plans for an invasion of Haiti, utilizing both Cuban exiles of his own group and Haitian exiles of a group led by Pierre Rigaud. Rigaud is living in Puerto Rico but will be included in the invasion. Masferrer has issued an invitation to selected Cuban exiles in Miami to participate.

Masferrer has a large cache of firearms for use in the invasion. These arms were last seen by me at the above address, 2368 Southwest 12th Street. They include the following:

- Ten .30 caliber and .50 caliber machine guns
- Two bazookas
- One 57 mm. recoilless cannon
- Fifty M-1 Carbine rifles
- Two-hundred Gyrojet Rocket Handguns and miscellaneous smaller arms
- Large supply of ammunition for above
