BRITISH SECURITY SERVICE, MI-5, ADVISES RECENT PRESS LONDON INDICATED SUBJECTS IN LONDON TO RECRUIT PERSON TO ACT ON BEHALF OF A SEPARATIST MOVEMENT ON THE ISLAND OF ABACO IN THE CARRIBEAN. BOTH ARE U. S. CITIZENS. MARGER, AGE 44, WERBELL, AGE 55 AND IS PRESIDENT OF DEFENSE SYSTEMS INTERNATIONAL INC., POWDERSPRINGS, GEORGIA. NO OTHER IDENTIFYING DATA AVAILABLE. ABACO IS BRITISH COLONY.
