In describing the purpose of his registration, Marger stated he had been appointed for the purpose of promoting the establishment of new industries and the development of trade on behalf of the Dominican Republic. He described his duty as an attempt to interest business people in investing their money in the Dominican Republic "either in conjunction with the Dominican Republic, either public or private, or alone."
