Re Bureau airtel dated 4/25/67.

NY 4498-C-TE advised on 4/26/67, that he does not know the names of the police officials or Assistant Mayor of New Orleans who were reportedly on the payroll of CARLOS MARCELLO, New Orleans underworld leader. Informant said that these officials appeared at the Town and Country Motel at different times while informant was in New Orleans. SAM DOMINO pointed these individuals out to informant and remarked as to their occupation and the fact they were on the payroll. Informant can not attest to the truth of this information from DOMINO.

Informant advised he took the trip to New Orleans on instructions from CARMINE TRAMUNTI. When leaving New York, the informant merely knew he was to see CARLOS MARCELLO about a job to be done. Informant said that he learned from MARCELLO that the job was to rob a New Orleans bookmaker, not further described. Informant said that MARCELLO was to provide a man to work with informant. Informant never met this other man.

Informant advised that after staying in New Orleans a week he was told by SAM DOMINO to return to New York City. DOMINO told him the job was called off because District Attorney GARRISON's investigation of the KENNEDY assassination was causing too much heat.
