Re Las Vegas teletype to Bureau, 12/29/66; Las Vegas airtel to Bureau, 1/3/67, copies not furnished New York and Washington Field Office.

Undersheriff LLOYD BELL (NA), Clark County Sheriff's Office, has requested exemplified copies of subject's conviction. BELL further advised that the Sheriff's Office has received non-specific information which indicates that ROSELLI has claimed that he has received a pardon for his conviction in New York in 1943.

For information of Los Angeles, LV 287-C advised SA LEWIS A. FAIN on 12/15/66, that subject had made an airline reservation to leave Las Vegas on Wednesday, 12/7/66, with two other individuals. ROSELLI subsequently cancelled this reservation. One of the individuals who was to accompany ROSELLI was a man by the name of JOHN MURPHY, who at that time was a guest in Room 2807 at the Desert Inn Hotel. MURPHY, according to information received by the informant, was an attorney.

Informant advised that MURPHY eventually left the hotel on 12/9/66, and ROSELLI departed from the hotel on
