On 1/23/67, the facts concerning ROSELLI's true identity as PHILIP SACCO were discussed by SAs HAROLD F. DODGE and NEWTON E. YOST with AUSA RICHARD COLEMAN, Chief, Special Prosecutions Unit, U. S. Attorney's office, Los Angeles, California.

A comprehensive review of the facts of the Bureau's investigation concerning PHILIP SACCO was given to Mr. COLEMAN. He was advised concerning the birth record of PHILIP SACCO in Italy, his arrival in the U. S. with his mother, his early life in Boston, his change of name to JOHN ROSELLI in about 1923, his life since coming to Los Angeles in the mid 1920's, and his delayed birth certificate filed in Chicago in 1936.

Mr. COLEMAN was advised that the only individuals (LA 4448-C-TE and TANCREDI TORTORA) who could testify to
