 AN ESTABLISHED SOURCE, STATED THAT ORLANDO BOSCH AVILA, ON SEPTEMBER 22, THE DAY AFTER LETELIER'S DEATH, STATED HE BELIEVED THAT THE NOVO BROTHERS WERE RESPONSIBLE FOR LETELIER'S DEATH AND THAT THE ACTION WAS TAKEN IN BEHALF OF DINA. (X)

ON NOVEMBER 1, 1976, DADE COUNTY DETECTIVE RAUL DIAZ ADVISED THAT [RICARDO MORALES NAVARRETE, A VENEZUELAN INTELLIGENCE OFFICIAL] TOLD HIM ON OCTOBER 23, 1976, THAT BOSCH MADE THE FOLLOWING STATEMENTS [TO HIM (NAVARRETE)] REGARDING THE LETELIER ASSASSINATION: (X) (S) (u)

DURING EARLY 1975, GUILLERMO NOVO VISITED CHILE, AT WHICH TIME HE ALSO VISITED ORLANDO BOSCH. NOVO, DURING THIS TRIP TO CHILE, MADE CONTACT WITH AN ULTRA RIGHT WING CHILEAN POLITICAL ORGANIZATION KNOWN AS "PATRIA Y LIBERTAD" (FATHERLAND AND LIBERTY). BOSCH STATED THAT ORLANDO LETELIER'S DEATH WAS THE RESULT OF AN AGREEMENT BETWEEN GUILLERMO NOVO AND THE PATRIA Y LIBERTAD ORGANIZATION. (X)(u) chile

[REDACTED] (S)(u) AND ATTEMPT TO OBTAIN DETAILS OF COMMENTS PREVIOUSLY

MADE BY [REDACTED] TO LEGAT. (S)(u)

IN VIEW OF THE POSSIBILITY THAT [REDACTED] (S)(u) CAN BE CONTACTED AND INTERVIEWED BY THE LEGAT AND BECAUSE OF THE EXTREMELY SENSITIVE NATURE OF THE CONTACT, WASHINGTON FIELD IS HOLDING IN ABEYANCE ANY CONTACT WITH THE STATE DEPARTMENT REGARDING THIS MATTER UNLESS ADVISED TO THE CONTRARY BY THE BUREAU. (S)

IN COMPLIANCE WITH BUREAU INSTRUCTIONS, ASSISTANT UNITED STATES ATTORNEY (AUSA) EUGENE M. PROPPER, MAJOR CRIMES UNIT, UNITED STATES ATTORNEY'S OFFICE, WASHINGTON, D.C., WAS CONTACTED ON THE MORNING OF DECEMBER 3, 1976, AND ADVISED THAT THE FEDERAL BUREAU OF INVESTIGATION'S (FBI'S) DESIRE TO HAVE NO FURTHER CONTACT WITH [REDACTED] UNTIL (S)(u)

AFTER THE COMPLETION OF THE TRIAL OF ORLANDO OTERO IN FLORIDA ON VARIOUS LOCAL BOMBING CHARGES. PROPPER STATED THAT HE WAS UNABLE TO SEE THE NECESSITY FOR DELAY IN THE INTERVIEW OF [REDACTED] (S)(u) SINCE THE INTERVIEW WOULD BE CONFINED SOLELY TO THE FACTS IN THIS MATTER AND WOULD IN NO WAY JEOPARDIZE THE OTHER CASE PENDING IN LOCAL COURT. PROPPER INQUIRED SPECIFICALLY WHETHER THE FBI WAS AWARE OF [REDACTED] (S)(u) PRESENT WHEREABOUTS AND STATED THAT HE COULD NOT UNDERSTAND THE RELUCIANCE OF THE BUREAU TO HAVE NO CONTACT WITH HIM UNTIL AFTER THE TRIAL. PROPPER WAS THEN ADVISED OF THE NATURE OF THE FBI RELATIONSHIP WITH [REDACTED] (S)(u) AND THE PROBLEMS THAT HAD ARISEN IN CONNECTION WITH HIS TESTIMONY IN THE FUTURE TRIAL REGARDING ORLANDO OTERO. HE WAS ALSO ADVISED THAT THE FBI WAS CURRENTLY ATTEMPTING TO EFFECT AN INTERVIEW OF [REDACTED] (S)(u) IN VENEZUELA TO ELICIT THE DESIRED INFORMATION IN THIS MATTER. (S)(u)
