Inasmuch as subject is registered with Registration Section, Department of Justice, as representative of Israeli Government-controlled organization, further investigation in this matter does not appear warranted. In the event you receive information indicating subject is operating outside the scope of his registration or is engaged in intelligence activities, advise Bureau and reinstitute an investigation. Based on information set forth in referenced communication, this matter should be closed in your office.

NOTE: Subject self-employed in general public relations work, Washington, D. C. He is registered with Department of Justice as representative of Republic of Nicaragua and Israeli military industries. Subject registered to import arms, ammunition and implements of war from Israel to U.S. In July, 1958, [subject was in contact with the Israeli Embassy, at which time he discussed in general terms a matter in which subject and the Israeli Military Attache had a mutual interest.] He also requested [the Israeli Military Attache] to furnish the details of a speech to be made [by the Military Attache] to an unidentified individual. Inasmuch as subject is a registered agent for the Israeli Government [and his contacts with the Israeli Embassy are general in nature,] no further investigation is deemed necessary in this matter at this time.
