I. IRVING DAVIDSON

On November 13, 1958, an informant who has furnished reliable information in the past, advised that I. Irving Davidson, who had recently returned from a visit to Israel and to Europe, had been in contact with Colonel Aharon Yariv, Military, Naval and Air Attache for the Israeli Embassy, Washington, D. C. (S) (ISRAEL)

Davidson reported having seen Shimon Peres of the Ministry of Defense in Israel who reported to Davidson, off the record, that he would be coming to the United States about December 10 or 11, 1958. (S) (U.S.A.)

Davidson requested that Yariv notify personnel of the Israeli Embassy that he, Davidson, was registered for the Israeli Military Industries at the present time. Davidson called to the attention of Yariv that there had been some information in the newspapers about Israel shipping machine guns into the United States. Davidson reported he would not be doing anything for about thirty days, after which time he expected to engage in public relations work. He desired that Israeli Embassy personnel be notified of his registration and in the event Yariv is asked concerning Davidson, Yariv should advise that Davidson is accredited and is the official representative of the Israeli Military Industries. (S)

Informant noted that Davidson had in his possession a grenade which Davidson described as a MI-2 grenade with a special attachment for using it. However, Davidson did not know how to use the grenade and requested that Yariv instruct him in its use. (S)

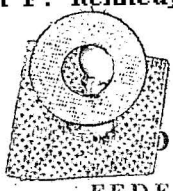

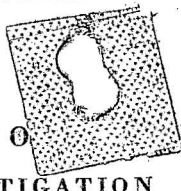

L. IRVING DAVIDSON

On November 13, 1988, an informant who has furnished reliable information in the past, advised that L. Irving Davidson, who had recently returned from a visit to Israel and to Europe, [had been in contact with Colonel Sharon Tzivy, Military, Naval and Air Attache for the Israeli Embassy, Washington, D. C.] (S)

Davidson reported having seen [Sharon Tzivy of the Ministry of Defense in Israel] who reported to Davidson, off the record, that he would be coming to the United States about December 10 or 11, 1988. (S)

Davidson requested that [Tzivy notify personnel of the Israeli Embassy that he, Davidson, was registered for the Israeli Military Industries at the present time. Davidson called to the attention of [Tzivy] that there had been some information in the newspapers about Israel shipping machine guns into the United States. Davidson reported he would not be doing anything for about thirty days, after which time he expected to engage in public relations work. He desired that [Israeli Embassy personnel] be notified of his registration and in the event [Tzivy is asked concerning Davidson, Tzivy should advise that Davidson is accredited and is the official representative of the Israeli Military Industries.] (S)

Informant noted that Davidson had in his possession a grenade which Davidson described as a M-1 grenade with a special attachment for using it. However, Davidson did not know how to use the grenade and requested that [Tzivy] instruct him in its use. (S)
