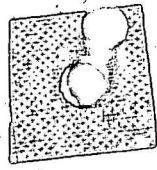

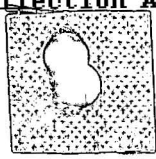

[I. Cohen] referred to in your 11/7/58 letter (S)
is identical with [Itzhak Cohen, Director, Government of
Israel, Ministry of Defense, Division of Supplies, 250 West
57th Street, New York 19, New York.] You may furnish this (S)
information to Colonel Faget for his information.

Enclosed for your information only is a copy of a
memorandum dated 5/16/58 concerning [Itzhak Cohen.] This (S)
information should not be furnished Faget in order to
protect our informant and since the information developed
concerning [Cohen] indicated he was [operating within the
scope of his duties] and since no information was developed (S)
to indicate he is engaged in [any activities of an intelligence
nature.] (S)

NOTE: Colonel Faget, a Havana source, requested any
identifiable information re [I. Cohen] who has had some dealings
with the subject. The subject has been given a letter of
credit by the Cuban Government. [I. Cohen is identical with
Itzhak Cohen.] SA sensitive informant (NY 14041S) was intro-
duced to [Itzhak Cohen by Jacob Kogon,] a business associate
of the informant who is [pro-Israeli.] Cohen mentioned to
the informant that [the Israelis] were interested in obtaining
the [latest information on the development of any weapons] (S)
in the U. S.; that [the Israelis heard the U. S. was developing
a gun sight for an aircraft air-to-air missile] that could [fire
on enemy aircraft 50 miles away.] (S) New York investigation (S)
failed to indicate that the subject was [engaged in intelligence
activities] (S)

The Bureau's attention is directed to Bufile [105-70008] in the case entitled, "ITZHAK COHEN, aka, Israel Cohen; IS-ISRAEL. Bureau's attention is specifically directed to the WFO report of SA GERARD C. CARROLL, dated July 21, 1958, and to letterhead memorandum dated May 16, 1958, at N.Y., N.Y. Report of SA CARROLL sets out information concerning contacts between [COHEN] and DAVIDSON, reportedly a registered agent for the government of Nicaragua.

Since it would appear that sufficient information suitable for dissemination concerning [COHEN] is available in the 2 communications listed above, no further action is being taken by this office.
