I. IRVING DAVIDSON

On February 13, 1959, an informant, who has furnished reliable information in the past, reported that I. Irving Davidson, a Washington, D.C. public relations counsel, and who is registered as an agent for the Government of Israel, had been in contact with an individual in Florida, whom Davidson said was "one of the top Cubans." (u)

Also in attendance when Davidson met the Cuban was one Holi, who is possibly identical with Colonel Kollnescher, formerly Assistant Military Attache of the Israeli Embassy. (S) Davidson has reported he feels something can be worked out and that someone is walking around with a bulk of money, but it would take some time to come to an agreement. Davidson and Kollnescher have talked to some unidentified general who knows someone who can be helpful. (u)
