On March 19, 1959, an informant, who has furnished JFK reliable information in the past, advised that I. Irving Davidson, Washington, D.C., public relations counsel and registered as an agent for the Government of Israel, reported to Avraham Salmon on a recent trip on which he was accompanied by Drew Pearson, syndicated news columnist

Davidson reported they had visited "Batista, Trujillo and all that gang, and Peron". Davidson described his contacts as "quite an interesting deal". Davidson stated he was very much involved in getting these peoples' papers straightened out. The informant said Davidson did not elaborate or identify the people concerned ()

Davidson reported to Salmon that it was not a dead issue but he could not get them to write a check that fast. Davidson arranged to see Salmon for drinks at the DuPont Plaza Hotel on the afternoon of March 19, 1959

The informant also recalled that Davidson reported being bothered again by "these Mexicans" who want to set up an Arcia (phonetic) plant ()

Avraham Salmon, according to the Diplomatic List published by the Department of State for February 1959, is the Economic Counselor at the Israeli Embassy (3)

Batista is possibly Fulgencio Batista, recently deposed pleader of Cuba (X(u))

Trujillo is possibly Rafael Trujillo, leader of the Dominican Republic (X)

Peron is possibly Juan Peron, deposed dictator of Argentina. $(\mathcal{H}(\mathcal{N}))$
