SUBJECT MOVIMIENTO INSURRECCIONAL DE RECUPERACION REVOLUCIONARIA (MIRR) IS-CU NM-CU

Re Bureau airtel dated 6/21/67, captioned as above, and Newark airtel and LHM dated 6/19/67, captioned "CUBNAT, IS-CU, NM-CU."

Referenced Buairtel instructed that LHM's be prepared on MIRR members. It further instructed that if information incorporated in the LHM's came from other agencies, clearance should be obtained from that agency prior to its being prepared for dissemination, since such dissemination would be made to [RCMP.]

Newark is currently preparing an LHM concerning the activities of ISRAEL ROMERO (Bufile 105-168688), who is active in behalf of the MIRR in N.J. Newark wishes to incorporate in its LHM on ROMERO, information furnished to Newark by [CIA source, JOSE ARIAS HERNANDEZ] which was furnished to the Bureau in referenced Newark airtel and LHM.

REQUEST OF BUREAU

The Bureau is requested to obtain clearance from CIA to permit inclusion in an LHM of information furnished by its source, JOSE ARIAS HERNANDEZ. Newark will withhold submission of its LHM on ROMERO until clearance has been received.
