Attached for each office, except Ottawa, is copy of Legat, Ottawa, tel 6/10/68, which is self-explanatory. (JFK)

(Bureau has no information indicating that the captioned group has made a threat against BOAC planes in Canada, the U.S. and Bermuda.) Recipient offices, except Ottawa, immediately check indices and appropriate sources for any information having a bearing on this matter. (Bear in mind the possibility that some other group may have made this threat and in reaching Canadian sources it may have been interpreted to have originated with the captioned group.) Suairtel unless urgency of situation indicates more expeditious handling.

Attached for Ottawa is copy of teletype disseminated by the Bureau on 6/8/68 to the Department of State and other interested agencies concerning the MIRR and three unknown subject cases. (Note therein the reference to a two-page letter signed by a Cuban Power representative which denounces countries trading with Cuba and sets forth an ultimatum demanding that these countries suspend all commerce with Cuba otherwise their ships and planes would be dynamited. It is not known if this is the matter referred to in referenced Ottawa tel, however, the information contained in the attached communication may be disseminated to the RCMP.)
