On 4/8/68, records of the Division of Motor Vehicles, Trenton, N.J., were checked by SA JAMES R. CARTER at which time it was determined that license number LYA 312 was issued to HECTOR ALFONSO, 99 Clifton Terrace, Weehawken, N.J., for a 1959 Pontiac sedan, serial number L1026.

On 5/3/68, Mrs RUTH WILKINS, Clerk, INS, Newark, N.J., made available INS file # A12 809 191 in the name of HECTOR ALFONSO RUIZ. This file reflects ALFONSO was born 5/12/39, in Havana, Cuba, and entered the United States at New York City, on 8/8/64, from Spain as a permanent resident alien. He was destined in the United States in care of MANUEL RODRIGUEZ DIAZ, 341 SW Fifth St., Miami, Fla. He was accompanied by his wife MATILDE MARTINEZ. He had no children. His father and mother were listed as FRANCISCO ALFONSO and ELENA RUIZ, both residing at Puentes Grandes # 2501, Cerro, Havana, Cuba.

On his INS application for permanent residence, ALFONSO indicated that he had been a member of the following organizations:

This report contains allegations that while in asylum in the Uruguayan Embassy in Havana, Cuba, in 1963, ALFONSO and several others comported themselves in a manner indicating possible ties with Cuban intelligence. This allegation was not substantiated by the investigation.

It is noted that no record could be located for HECTOR ALFONSO RUIZ at either the Weehawken, NJPD, or at the Garden State Credit Bureau, Clifton, N.J.

The following confidential informants, who are familiar with some Cuban refugee activity in the New Jersey area, advised when contacted as follows that they had no knowledge of ALFONSO.

It is noted ISRAEL ROMERO, supra, has advised that HECTOR ALFONSO is currently a member of the MIRR and works closely with him in MIRR projects.

REQUEST OF THE BUREAU

In line with the continuing efforts of this office to develop additional sources and informants within Cuban refugee organizations, it is felt that an interview with HECTOR ALFONSO is desirable. Accordingly, Bureau authority is requested to interview ALFONSO for the twofold purpose of obtaining whatever information he may have concerning the activities of the MIRR and to assess his potential as an informant. If he should prove cooperative, no affirmative steps will be taken during the interview to direct his activities, but a separate communication will be submitted to the Bureau containing recommendations.
