For information Miami and San Juan, [Legal Attache  
(Legat), Mexico City, by teletype dated 7/18/68 advised that  
(S) CIA official accompanying captioned individuals in Mexico  
had contacted Office of Legat, Mexico City, 7/18/68 advising  
that the [Spanish] officials had arrived in Mexico and had (S)  
examined [Spanish] property in that country and had conferred with  
Mexican officials regarding possible attack by Cuban Power  
against Spanish establishments.] (G-1)(u)

(S) The [CIA] (S) official had stated that the [Spanish] (S) visitors  
would be departing from Mexico for New York and would arrive  
in that city evening of 7/19/68 for scheduled briefing by  
Bureau representatives there. [The Spanish officials have (S)  
expressed considerable appreciation for briefing given them by  
SAC, San Juan, and SAs at Miami. They had noted they had  
made discreet notes of these conferences but would appreciate  
receipt of written reports which might be available to assist  
them in preparing their final report on returning to Spain.] (G-1)(u)

New York has been instructed to conduct briefing  
of captioned individuals in accordance with prior instructions  
(2-1) in instant matter but to abstain from committing Bureau to  
giving any written reports of the nature described above.

Airtel to Miami

Re: [LORENZEO CALATAYUD DE LA HOZ] (G-1)(u)

Should captioned individuals request written reports, in line with referenced telephone call the New York Office will advise them that no such reports are available in that office but that the question will be referred to Bureau headquarters for consideration.

Miami, San Juan, and New York should by return airtel submit LHM suitable for dissemination containing details of subject matters involved [during briefing by those offices of the Spanish officials.] The material will be analyzed by Bureau [G-1][U] and determination made with regard to question of dissemination. Dissemination may be accomplished through [Legat at Paris.]

This matter must be given expeditious handling to assure that if information is furnished to the Spanish Government it may be done at an early date. (G-1)(u)

NOTE:

(G-1)(u) [Subjects are Spanish Internal Security Service members who have been traveling in U. S. and Mexico surveying Spanish establishments and attempting to obtain information for protection of such establishments in view of threats against them by Cuban Power.] [They have been accompanied in their travels by a CIA [G-1][U] representative.] We previously instructed Miami, San Juan and New York Offices to cooperate with these officials to the point of briefing them concerning the bombing threats which have been received to date and putting them in touch with appropriate local police officials.

Re Bureau telephone call was made by Section Chief W. R. Wannall to New York Supervisor Harry Hoeg this date and instructions herein are designed to provide cooperation with the request of the [Spanish authorities] as noted by [Legat, Mexico City.]
