We refer to your letter dated April 16, 1969 concerning the above named.

According to information obtained from the Geneva Police, BENTON was arrested on February 13, 1969 at Geneva for attempted fraud. He was charged with this offence as well as with the offence of using a forgery. BENTON was released on February 20, 1969 and left Switzerland that day by air for Frankfurt/Germany. The case was shelved by the competent Geneva authority.

Through administrative measures taken by the Aliens Police, BENTON is banned from entering ^{INTERPOL SUISSE} Switzerland before February 20, 1979. His present whereabouts are unknown to us.
