1. MINA VOELLMY, <sup>\*</sup>NOW ATTACHED TO DENVER OFFICE. WE WERE NOT ABLE TO REACH HER BY PHONE. SHE IS ON MATERNITY LEAVE AND HOME PHONE DID NOT ANSWER (IT IS 777-0615, DENVER). ALL WE CAN TELL FROM OUR RECORDS IS THAT MINA PROBABLY SAW THE LADIES IN SOLVANG ONLY ONCE (AFTER THEIR RETURN FROM THE USSR). MINA WILL PROBABLY REMEMBER SOME THINGS NOT REFLECTED BY OUR FILE. SUGEST YOU TRY TO PHONE HER. BUT WE ARE SURE MINA DID NOT SEE THE LADIES BEFORE THE TRIP AND CERTAINLY NOT (BY US) DURING THE TRIP.

2. FILE CARDS INDICATE MINA DEBRIEFED MISS RITA NAMAN AND MRS. MONICA FAUERSO KRAMER, BOTH OF 596 ATTARDEG ROAD, SOLVANG (130 MILES NORTH OF LOS ANGELES) ON 7 MARCH 62. NOTATION ON BOTH CARDS READS, "VERY COOPERATIVE".

SLIDES DIRECT TO MRS. KRAMER ON 17 <sup>MAY</sup> 62 WITH INTERESTING COMMENT  
"MOST OF THE SLIDES ARE OF THE USUAL TOURIST VARIETY AND HENCE ARE  
OF LITTLE VALUE." OF THE 166 SLIDES FIVE WERE "ACCESSIONED."
