1. Attached is a sealed letter from [redacted]

[redacted] (who provided a copy of the letter to the Chief of Station, [redacted], and a suggested reply for your signature.

2. [redacted] letter to you recommends against declassification of the Warren Commission document CD-971, which refers to our investigation of [redacted] before and after the assassination of President Kennedy.

3. I consider the points made by [redacted] in his letter to be valid and accordingly recommend against the declassification of CD-971 in the foreseeable future. CI Staff concurs with this recommendation.
