- THE FOLLOWING INFORMATION HAS BEEN CATHERED FROM RELIABLE SOURCES REGARDING THE TRAVEL OF LEE HARVEY OSWALD AND HIS WIFE:
- 9 OCTOBER 1959: ACCORDING TO OFFICIAL ERITISH TRAVEL RECORDS OSWALD ARRIVED IN SOUTHAMPTON THIS DATE CLAIMING ON HIS LANDING CARD THAT HE HAD HO FIXED ADDRESS BUT PLANNED TO REMAIN IN THE UNITED KINGDOM ONE WEEK FOR VACETION BEFORE GOING ON TO "SOME SCHOOL IN SWISSE." (HEADQUARTERS COMMENT: PROBABLY REFERRING TO THE ALBERT SCHWETTZER COLLEGE IN SWITZERLANDSWIELD, WHILEWILLE IS KNOWN TO HAVE BEEN IN CORRESPONDENCE.)
- 10 OCTOBER 1959: ACCORDING TO THE SAME OFFICIAL $rac{2}{22}$ records oswald left london this date by Air for Helsinki.
- OCTOBER 1959: STOCKHOLEM NEWSPAPER "DAGKINS NYHETER" OF 25 NOVEMBER 51963 STATES LEE OSWALD PASSED THROUGH SWEDEN DURING OCTOBER 1959. ARTICLE ALSO Sadds that oswald was unsuccessful in obtaining visa to the ussr in heiskinki which RESULTED IN HIS RETURNING TO STOCKHOLM. TWO DAYS AFTER HE ARRIVED IN STOCKHOLM CONCLUDING SENTENCE OF ARTICLE STATES "THIS indicates that the Russian Embassy (Stockholm) gave him a visa." According TO A RELIABLE SOURCE THERE WAS NO RECORD THAT THERE WAS ANY REQUEST FOR A USSR VISA PROCESSED THROUGH NORMAL CHANNELS FOR OSWALD AT ANY TIME DURING 1959, AND 201-289248 Video-5-41 COORDINATING OFFICERS

SOURCE INDICATED IT WAS DIFFICULT TO EXPLAIN HOW OSWALD MIGHT HAVE RECEIVED HIS VISA IN TWO DAYS WITHOUT GOING THROUGH NORMAL CHANNELS. THE ONLY CONCLUSION WHICH CAN BE DRAWN IS THAT OSWALD MUST HAVE RECEIVED HIS VISA DIRECTLY FROM THE SOVIET EMBASSY IN STOCKHOLM WHICH OCCASIONALLY IS DONE IN SPECIAL CASES, BUT THE SOURCE HAD NO EVIDENCE TO CONFIRM THIS ASSUMPTION.

- 10 TO 15 OCTOBER 1959: ACCORDING TO A VERY RELIABLE BUT EXTREMELY SKRSTTIVE SOURCE CSWALD STAYED AT THE TORNI HOTEL IN HELSINKI FROM 10 TO 11 OCTOBER AND THEN MOVED TO THE KLAUS KURKI HOTEL WHERE HE STAYED UNTIL 15 OCTOBER, APPARENTLY WAITING FOR A VISA TO BE ISSUED HIM BY THE SOVIET CONSULATE IN HELSINKI. HE TRAVELED TO THE USER BY TRAIN, CROSSING AT VAINIKKALA ON 15 OCTOBER.
- 13 MAY 1962: ACCORDING TO A DUTCH OFFICIAL SOURCE, THE DUTCH CHARGE IN MOSCOW ISSUED A TRANSIT VISA TO OSWALD'S WIFE ON 13 MAY 1962. THERIR RECORDS REVEAL HIS WIFE WAS BORN ON 17 JULY 1941 INSTRAD OF 19 JULY 1941 AND IN SEVERODVINSK INSTEAD OF MINSK. THERE IS NO RECORD OF HER HAVING ACTUALLY TRANSPIED THE NETHERLANDS.
- 1962: OFFICIAL BRITISH RECORDS DO NOT REFLECT THAT OSWALD RETURNED. TO THE UNITED STATES FROM THE USER THROUGH THE UNITED KINGDOM. HOWEVER, IF HE WERE MERELY TRANSITING, IT WOULD NOT HAVE BEEN NECESSARY FOR HIM TO FILL OUT A LANDING CARD, AND THEREFORE THERE WOULD BE NO RECORD OF HIS TRAVEL IN THE
