1. Attached for Headquarters' information are the following three SYMPATHIZER reports:

a. CAH/63/795, dated 3 December 1963, which is the result of the SYMPATHIZER investigation of OSWALD's transit through The Netherlands in June 1962. As will be noted, their check with the Holland America Line confirmed the already well-known fact that OSWALD sailed on the ss. MAASDAM on 4 June 1962, together with his wife and child, from Rotterdam to New York. No new information was gained by SYMPATHIZER, however. The Dutch newspaper article referred to in this report mentions the fact that OSWALD, after arrival in New York, was contacted by his brother, name and address not given. Nothing else of interest is in this article.

b. A BUSYBODY report of 1 December 1963, concerning a telegram received by the Cuban Embassy in The Hague, from Havana.

c. SYMPATHIZER "AC" report #56, dated 2 December 1963, which was reported previously by the Station in HAGU-5063.

2. The TDY transcriber sent to The Hague on 4 December 1963 is in the process of listening to the tapes which contain mention of the assassination. Thus far, nothing of interest bearing on this matter has been picked up from these tapes. We will of course inform Headquarters by cable if and when any further pertinent information is obtained.

SUBJECT: Lee Harvey OSWALD and wife.

In compliance with your oral request for information on subject and his wife we state as follows.

- 1) Marina Nikolajevna P(R)USAKOVA, born Sewerodwinsk, province of Archangelsk, 17 July 1941, wife of Lee Harvey OSWALD, American, born 18 October 1939, was issued a transit-visa for the Netherlands on 30 May 1962 by the Netherlands Embassy in Moscow under no. 249-NE 62.
- 2) On 3 June 1962 Mrs OSWALD entered the Netherlands via Oldenzaal Station, presumably accompanied by her husband and daughter JUNE.
- 3) On 4 June 1962 the three departed by the s.s. "MAASDAM" of the Holland-America Line to the United States. This communication was received from the Rotterdam Police. See also the publication in "DE TELEGRAAF" of 30 November 1963.

RODRIGUEZ phones the following telegram to DIAZ, which was received from CASTRO:

After the assassination of President Kennedy, facts have been bringing up to light a sinister plot. Contradictions reveal that Oswald was either convicted by the Police or prepared to plan the assassination (not clear), with the promise of letting him escape afterwards, so as to insinuate or make the responsibility fall upon those whom the actual authors wanted to blame. It is clear that reactionary North Americans wanted to make Cuba and the world victims of their criminal purposes even at the extent of assassinating the President. They sent Oswald to Mexico to ask for an in-transit visa for Cuba and then go to the USSR. Imagine the President's assassin just returning from the USSR and going to Cuba! He could have asked for an USSR visa in some European countries much much closer than Cuba without coming to Cuba and then returning to the USSR.

On or about 1970 we will be able to surpass 10 millions tons of sugar and export it. Economy is getting firmly better. We have already sold sugar at about 10 cents for 1965 or 1966. By the end of this year, nougat, wine and grapes will reappear in the market as a result of the exterior commerce.

Vernomen werd, dat de 3e Secretaris van de Ambassade van Cuba in Den Haag, Ricardo SANTOS MESA, tijdens de receptie van de S.U. op 7 november j.l.^{OP} een vraag van één der aanwezigen naar de reacties van CASTRO op de aanvallen van Cubaanse ballingen op Cuba, antwoordde: "Just wait, and you will see what we can do; it will happen soon".

SANTOS weigerde hierop verder in te gaan.

Vernomen werd nog, dat SANTOS een broer heeft, die als "balling" in de Verenigde Staten van Noord Amerika woont.

Hoewel zelf pro-Castro, zou zijn broer op aandringen van zijn conservatieve echtgenote zijn uitgeweken.

Met deze broer zou SANTOS in briefwisseling staan.
