I. AT 1655 ON 7 MAY 1974 WE RECEIVED A TELEPHONE CALL ON THE LISTED LINE FROM FRANK STURGIS, WHO INDICATED THAT HE WANTED TO MILET WITH US AS SOON AS POSSISLE IN ORDER THAT HE MIGHT CONVEY INFORMATION OF EXTREME IMPORTANCE TO THE AGENCY. HE MENTIONED AT THE OUTSET THAT HE HAD ARRANGED TO MEET WITH FIELD OFFICE AT AN EARLIER DATE.

FIELD OFFICE AT AN EARLIER DATE,
BUT HAD FAILED TO APPEAR AT THE APPOINTED TIME AND
PLACE. WE DID NOT COMMENT ON THE ABORTIVE MEETING;
HOWEVER, WE IMMEDIATELY ADVISED STURGES THAT WE ARE NOT IN
A POSITION TO MEET WITH HIM. WE SUGGESTED THAT IF HE
REQUIRED AGENCY CONTACT HE SHOULD DO IT AT THE WASHINGTON
LEVEL. HE ASKED WHO IN WASHINGTON HE MIGHT CALL. WE

HE IMMEDIATELY SAID THAT IT CONCERNED NARCOTICS IN MEXICO AND THAT
