1. AT 1655 ON 7 MAY 1974 WE RECEIVED A TELEPHONE CALL ON THE LISTED LINE FROM FRANK STURGIS, WHO INDICATED THAT HE WANTED TO MEET WITH US AS SOON AS POSSIELE IN ORDER THAT HE MIGHT CONVEY INFORMATION OF EXTREME IMPORTANCE TO THE AGENCY. HE MENTIONED AT THE OUTSET THAT HE HAD ARRANGED TO MEET WITH MATT MACVANE OF THE MIAMI FIELD OFFICE AT AN EARLIER DATE, BUT MACVANE HAD FAILED TO APPEAR AT THE APPOINTED TIME AND PLACE. WE DID NOT COMMENT ON THE ABORTIVE MACVANE MEETING; HOWEVER, WE IMMEDIATELY ADVISED STURGIS THAT WE ARE NOT IN A POSITION TO MEET WITH HIM. WE SUGGESTED THAT IF HE REQUIRED ASENCY CONTACT HE SHOULD DD IT AT THE WASHINGTON LEVEL. HE ASKED WHO IN WASHINGTON HE MIGHT CALL. WE INDICATED THAT WE WERE UNABLE TO SUGGEST A SPECIFIC NAME.

2. STURGIS THEN SAID THAT HE DIDN'T WANT TO PLAY GAMES AND THAT HE WAS PREPARED TO GIVE US HIS INFORMATION OVER THE TELEPHONE.
