PERUEN C/S COMMENT: *RE CLEAN EXILE JULIO LANIER GIVEN MONEY BY VENEZUELA FAP OPS AGAINST CASTRO. PEOPLE HQS ADVISE RE AIDING LANIER.
REF: MEXI 6301 (IN 28178)*

1. BASIC HQS POSITION IS TO RENDER ASSISTANCE ANY RESPONSIBLE GROUP CARRYING FIGHT TO CASTRO. JURE FALLS IN THIS CATEGORY AND HQS INTERESTED IN EFFECTING PROCUREMENT AS WELL AS RECEIVING DETAILS THEREOF. WHILE OBVIOUSLY DO NOT WISH HAVE L-2 INVOLVED IN ANY OVERT EXHIB ACTIVITY, THERE NO OBJECTION L-2 RENDERING PURELY COVERT ASSISTANCE PROVIDED DOES NOT JEOPARDIZE HIS OPS UTILITY. RECOMMEND LANIER CONTACT BE MAINTAINED AND HQS KEPT ADVISED.

2. JULIO LANIER KEVIA WAS ONE OF ORIGINAL ~~MEXICAN~~ BLOC PRO-UNION CURAMA EN REBILIO (MEXICO) FORMED FEB 1962. INITIALLY HELD POSITION AS [REDACTED] (SEE MEXI 6233, FROM LITANIL-4). NO OTHER TRACES.

3. MANOLO RAY AND ~~REDACTED~~ ESTANISLACOURT (MEXI 6255) OF ECL HAVE HAD DEALINGS IN THE PAST AND HAVE JOINTLY ATTENDED DISCUSSIONS WITH CUBAN OFFICIALS ON CURAN REFORM. IT POSSIBLE THEREFORE THAT BOTH LANIER AND ESTANISLACOURT APPROACHES ARE RELATED.
