Moreover, the cover unit was dissolved in 1968.</p> <p>However, Kail, like many other military personnel assigned to the Agency then and since, was on covert detail at the time (apparently 1962-66), and this fact should be protected because of our cover arrangements with the Military. Therefore, recommend the Committee be requested to treat this file (and any other Agency records on Kail) as CONFIDENTIAL.</p> <div style="border: 1px solid black; width: 50px; height: 20px; margin: 10px auto;"></div> <p><i>1 to 3: No need to show this to HSCA. 2. Although the above documents are unclassified, the fact that Subject was affiliated with the Agency should be treated as CONFIDENTIAL because he was on covert detail to the Agency from 1962-66. (C)
