1. In order to provide answers to the questions posed in paragraphs 9, 10 and 11 of reference we again have reviewed the files which were returned to Headquarters following the death of Winston Scott in Mexico City. These files are stored at the Agency Records Center in Virginia.

2. Reference paragraph nine any files which were maintained in the Staff on Lee Harvey Oswald presumably have been reviewed by the members of the House Select Committee on Assassinations. available in Mr. Russell Holmes' office. Regarding your request for any and all files maintained by James Angleton and/or the CI Staff that pertain to Mexico Surveillance Operations; there are several hundred reels of audio film stored in the Records Center which contain telephone coverage of the Soviet and Cuban Embassies in Mexico City for the period 22 November 1963 through 13 December 1963. A review of these tapes by persons from CI Staff and LA Division did not uncover any information pertinent to the assassination of President Kennedy. The period covered is subsequent to the time that Oswald was known to be in Mexico.
